- ❖ Club Membership includes privileges from January 1, 2021 through December 31, 2021. Members joining mid-year will pay an adjusted rate as determined by the Founders Group Membership Coordinator.
- ❖ Membership dues are non-refundable. Conduct detrimental to the use of the golf course, other members, guests and/or staff may result in termination of membership. Long Bay Club reserves the right to revoke or deny any memberships at any time.
- ❖ Proper golf attire is required.
- ❖ New membership golf will be \$20 for 18-hole rounds and \$12 for 9-hole rounds at Long Bay Club. (Restrictions may apply for 9-hole rounds.)
- ❖ Members may book starting times one week in advance. Starting times may be booked in the Golf Shop or by calling 843-399-2222.
- ❖ Each member may have up to three accompanied guests play golf for the “Guest of Member” rate. This rate will be equivalent to the Honors Club rate for that time period. Guests play may be limited.
- ❖ Members that fail to show up for, or properly cancel their tee times are subject to be charged the full value of the starting time.
- ❖ Club Membership includes an Honors Club Card and all its privileges. (Does not qualify for purchase bonus points or gift card.)
- ❖ Discontinued Club Memberships must wait 12 months to rejoin and will be subject to pay any applicable initiation fees at that time.
- ❖ Medical disruptions that result in the inability to use club privileges will be handled by the Founders Group Membership Coordinator. If approved, Club members may be eligible for a 75% reduction of monthly dues for a period of 2 to 6 months. Any credits will be applied to 2022 membership dues.

- ❖ New Social Members may golf twice a month at the rate of \$35 per member. (Restrictions may apply.)
- ❖ Social Members may book tee times 48 hours in advance. Tee times may be booked in the Golf Shop or by calling 843-399-2222.
- ❖ Social Members may have up to three accompanied guests play golf for the “Guest of Member” rate of \$40 per guest. Guest play may be limited.
- ❖ Members that fail to show up for, or properly cancel their tee times are subject to be charged the full value of the starting time.
- ❖ Golf clinics and lessons are available for Social Members.
- ❖ Use of the Long Bay pool is included with a Social Membership.
- ❖ Dinner and/or 9-hole golf events will be offered once a month.
